Science editor:

1 Scientific quality: The manuscript describes a minireview of the psychosocial factors affecting the etiology and management of type 1 diabetes mellitus. The topic is within the scope of the WJD. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: This is a very well written review article providing a summary of the most important psychosocial factors that influence the etiology and management of T1D in children and adolescents, with an emphasis on stressful life events and stress regulation inside the family dynamic. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 49 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%.

(1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (3) Please add table/figure to this review. 6 Recommendation: Conditional acceptance.

Comment 1: There are no tables and no figures.

Comment 2: A total of 49 references are cited, including 9 references published in the last 3 years. There are 3 self-cited references. The self-referencing rates should be less than 10%.

Additional references were added (reference nr. 14, 16, 24, 25, 28, 35, 36-42, 44-49, 54, 55, 57, 60-69, 75-81, 85-87, 90-93). Together there are 93 references, 13 of them are from last three years, 4 references are self-cited references.
