The topic is within the scope of the WJCC.</p> <p>(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors report the case of a 53 year old man who experienced a number of clinical signs and symptoms (dysphasia, localized kinetic tremor and mirror movement of the left arm) which appeared in the course of 18 months after an acute talamic haemorrhage; and (3)</p>	[Y]

Format: There are 2 figures. A total of 21 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editsprings was provided. 3 Academic norms and rules: The authors provided the written informed consent. However, the written informed consent of treatment was no provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (3) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
