A total of 131 references are cited, including 48 references published in the last 3 years. There are 5 self-citations (Ref. 28, 42, 85, 101, 102). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade A and two Grades B. The authors are native English speakers. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing.
