(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors retrospectively evaluated tumor tissues from 287 patients with GC, and MSI status, E-cadherin and p53 expression were analyzed by IHC, and EBV by ISH. Flowing by evaluating the clinicopathological characteristics and long-term survival of GC based on the subgroups of molecular classification. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 3 figures; (4) References: A total of 34 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
