2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the intestinal-specific effects of streptozotocin-induced diabetic and insulin-treated diabetic rats on ganglionic basement membrane thickness and the expression of MMP-9 and TIMP-1. The topic is within the scope of the WJG. (1) Classification:</p>	[Y]

Grade B; (2) Summary of the Peer-Review Report: The results established that the onset of diabetes was associated with ganglionic BM thickening in ileum but not in the duodenum, and that insulin treatment prevented the diabetes-related thickening of the BM surrounding the ileum mesenteric ganglia. Moreover, these changes were reflected in a decrease in ileum MMP-9/TIMP-1 ratio. This is interesting and well-presented study. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 7 figures; (4) References: A total of 62 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There are 8 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
