2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of the mechanisms involved in selecting and maintaining neuroblastoma cancer stem cell populations, and perspectives for therapeutic targeting. The topic is within the scope of the WJSC. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: The authors carefully summarized that origin</p>	[Y]

of neuroblastoma (NB) and the relationship of NB progression of cancer stem cell (CSC)-like subpopulations. However, the authors fail to provide their own perspective of the field since discussion of the presented evidence is almost absent. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. (4) References: A total of 488 references are cited, including 121 references published in the last 3 years; (5) Self-cited references: There are 38 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B and Grade B.
