2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a minireview of the large-duct pattern invasive adenocarcinoma of the pancreas. The topic is within the scope of the WJG. (1) Classification: Two Grades A and two Grades B; (2) Summary of the Peer-Review Report: Overall this is very interesting topic in pancreatic cancer with overall limited understanding. Review is in-depth and summarizing published literature very nicely.</p>	[Y]

Authors have done an excellent job in highlighting various features of large duct type adenocarcinoma macroscopically as well as in pathology. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 85 references are cited, including 23 references published in the last 3 years. There are 2 self-citations (Ref. 9, 25). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade A and three Grades B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Japan Society for the Promotion of Science (JSPS) KAKENHI. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
