and raise the perspectives of new biomarker exams and artificial intelligence. This paper will play a guiding role in the daily clinical work of doctors in related fields. The questions raised by the reviewers should be answered; (3) Format: There are 1 figure; (4) References: A total of 113 references are cited, including 52 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
