2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireview of the rectovaginal fistula after low anterior resection. The topic is within the scope of the WJGS. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors have presented a review of risk factors, evaluation, management, and outcome of patients who develop rectovaginal fistula as a complication of low anterior resection. The article does a reasonably good job in discussing contemporary literature on this</p>	[Y]

topic. The questions raised by the reviewers should be answered; (3) Format: There are 2 figures; (4) References: A total of 26 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
