2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case control study (Not a Frontier) of the clinical significance of serum miR-129-5p for macrovascular complications in patients with diabetes mellitus. The topic is within the scope of the WJD. (1) Classification: Two Grades B and Grade D; (2) Summary of the Peer-Review Report: This is an interesting study regarding early</p>	[Y]

identification of diabetic macrocomplications via a novel biomarker. The topic is of interest and the results are of relevance. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 2 figures; (4) References: A total of 30 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are 7 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
