Disease, Transplant, Abdominal surgery; most specially how the practice of medicine in each of the area of the specialty have been impacted and how that has changed the epidemiological-clinical picture of patients. Both clinicians and patients can benefit from it. The questions raised by the reviewers should be answered; and (3) Format: There are no tables and figures. (4) References: A total of 71 references are cited, including 62 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
