The topic is within the scope of the WJD. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The relationship between PAD and DM is a meaningful topic clinically. The topic this article focused can be useful for clinical practice. However, some shortcomings should be mended up. The questions raised by the</p>	[Y]

reviewer should be answered; and (3) Format: There is 1 figure. (4) References: A total of 74 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A.. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript.
