(1) Classification: Grade A, Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a very good meta-analysis manuscript dealing with preemptive strategies in order to prevent FSGS recurrence after kidney transplantation. It shows that nor rituximab nor plasmapheresis are able to prevent recurrence. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 5 figures; (4) References: A total of 46 references are cited, including 23 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
