The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors give a comprehensive review of the role of NK cells in pancreatic cancer. However, the role of NK cells in pancreatic cancer is still poorly defined. The questions raised by the reviewer should be answered;</p>	[Y]

(4) References: A total of 106 references are cited, including 28 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
