The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report:	[Y]

Although the authors expressed possible mechanisms for the observed transformation that exist in the literature, they did not propose their own hypothesis for this transformation for their patients; and (3) Format: There are 2 figures. (4) References: A total of 11 references are cited, including no references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation.
