the possible contribution of gut dysbiosis to COVID-19. The study presented in this review on the role of human microbiome in COVID-19 disease is very timely, comprehensive and pioneering, and would be a big contribution to the fighting against COVID-19 disease. However, the questions raised by the reviewer should be answered; and (3) Format: There are no tables and figures. (4) References: A total of 92 references are cited, including 91 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
