(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The aim of the study was to evaluate liver and gastrointestinal dysfunctions in a multicenter Egyptian cohort of patients with COVID-19 in the first months of the pandemic and to relate these results with COVID disease severity. The questions raised by the reviewers should be answered; (3) Format: There are 7 tables and 1 figure; (4) References: A total of 28 references are cited, including 27 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
