generation sequencing, for rapidly determining pathogens in clinical human samples, including bronchoalveolar lavage fluid and cerebrospinal fluid. It is interesting to see bacterial species other than those typical meningitis-causing bacteria identified in CSF. However, the questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 2 figures. (4) References: A total of 13 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
