WJGS. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: The animal results using the endoscopic device Souten is interesting. However, it still remains to answer whether the curative efficiency for early cancer using hybrid ESD is the same as conventional ESD; and (3) Format: There are 3 tables and 4 figures. (4) References: A total of 21 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an

invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Recommendation: Conditional acceptance.
