Peer-Review Report: The paper can be improved by refining grammar and a clearer background and discussion section. The paper describes how unenhanced MRI, which has improved in recent years, has superior sensitivity to US in detecting very small HCC. This is especially useful as early detection can result in improved prognosis. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. (4) References: A total of 40 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
