2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of removal of a pulmonary artery port catheter by using a pigtail catheter. The manuscript type designated by the author is consistent with the content of the manuscript. The topic is within the scope of the WJCC. (1) Classification: Grade A (1). (2)</p>	[Y]

Summary of the Peer-Review Report: The authors have described the successful management of a rare complication from an implanted intravenous infusion port. The treatment reported was considered to be innovative and of scientific value. (3) Format: There are 2 figures and no tables in the manuscript, and all figures are of high quality. (4) References: There are few references cited in the manuscript. A total of only 7 references are cited, of which 2 references were published in the last 3 years. (5) Self-cited references: There are no self-cited references in the manuscript. (6) References recommendations: The reviewers made no references recommendations. 2 Language evaluation: Classification: Grade A (1). The authors have provided a language editing certificate from MedSci. 3 Academic norms and rules: The authors have sent a Signed Informed Consent Form, which is correctly provided and meet the standard requirements. While the authors have denied any competing interests in the manuscript, a signed Conflict-of-Interest Disclosure Form was not provided. A CARE Checklist was sent by the authors. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: This is an unsolicited manuscript. Financial support was not disclosed in the manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the Conflict-of-Interest Disclosure Form. Please upload the aforementioned document. (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI

	<p>citation numbers to the references. (3) While the dates when then patient underwent mastectomy and when the rupture of the catheter was diagnosed are present in the manuscript, it is unclear when was the catheter implanted, and whether the rupture occurred immediately after implantation or chemotherapy infusion. Please consider clarifying these issues in the manuscript. (4) Consider changing the title of the manuscript to catheter rupture or catheter fractures, as these terms are used more commonly to describe this type of complication than the term catheter exfoliation. (5) The number of references in the article was considered to be low, please consider adding more references, particularly from articles published in the last three years. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
