AGREEMENT FOR COLLABORATION AND JOINT FUNDING OF RESEARCH PROJECT

“Understanding the molecular mechanism of asthma using systems engineering approach”

THIS COLLABORATION AND JOINT FUNDING AGREEMENT is made as of the February 27, 2019, by and between the University of Sharjah (UOS), and the Sharjah Research Academy (SRA), collectively referred to as the “Parties”.

WHEREAS, the regents of the Parties are mutually interested in research collaboration between their organizations, they have agreed to fund the above titled seed project to initiate such collaboration. The detailed project application is attached.

The terms of this agreement are as follows:

- A. The lead Party of the project is the University of Sharjah and the overall coordinator of the project is *Dr. Rifaat Hamoudi* from the University of Sharjah. The coordinator from the SRA side is *Professor Mufid Samarai*.
- B. Each Party coordinator is responsible for satisfying and adhering to the administrative requirements of his/her organization in relation to the project.
- C. The research investigators from the UOS are those listed in the attached application form. In addition, the SRA could appoint an investigator or more to join the research team during the conduct of the project.
- D. The overall coordinator is responsible for managing the scientific and technical affairs of the project. These include: (a) coordination of project tasks and schedule; (b) preparation of progress and final reports; (c) overseeing and approving all communications related to project conduct and outcomes; (d) project publications and investigators work; (e) determining the project’s needs and requirements; (f) informing the Parties of delays and obstacles affecting technical progress of project; and (g) any other relevant technical matters related to the project.
- E. The two organizations agree to equally share the estimated total project cost of AED 385,000, exclusive of salaries paid to employees of the two organizations and expenses related to use of their facilities and equipment. The agreed contributions of each Party are as listed in the Table below:

- F. In spending the project allocation to meet project needs, each Party shall adhere to its own financial rules and regulations. The SRA shall individually arrange with the UOS the optimal procedure for spending the funds in support of the project’s activities. These could include (i) direct expenditure and/or acquisition by each Party; or (ii) transferring funds to the project’s account at the UOS to cover the project’s needs subject to authorization by the overall coordinator, and concurrence of

- the transferring Party coordinator. In the latter case, the UOS shall submit periodic official statements of the relevant expenditures to the transferring Party as required.
- G. The appointment of the research assistants and research associates shall normally be administratively implemented through SRA in consultation with UOS. Exceptions shall be subject to written agreement of both parties
- H. Changes to the distribution of the contributions in the above table shall be subject to written agreement of both parties.
- I. The Parties shall meet their financial obligations in a timely manner to keep the project on schedule. In case of delays that may negatively affect the progress and scientific quality of the project, the overall coordinator shall inform, the Parties and seek a resolution to the reason for the delay and/or an extension of the duration of the project.
- J. The duration of the project is 24 *months* and the effective start date is *February 27, 2019*.
- K. The overall coordinator shall submit six-monthly progress report and an end of project final report to the Parties. Such reports shall be compiled from similar reports prepared by the Party coordinators.
- L. Although the nature of the project holds no promise of generating an invention, any invention conceived or produced jointly shall be jointly owned by the respective Parties.
- M. Each Party commits to informing the other Parties in writing of any changes that may affect the progress or implementation of the project.
- N. The investigators shall acknowledge funding received from the Parties in all publications that may be generated from the results of this project.
- O. In case investigators or coordinators can no longer work on the project, the Parties reserve the right to appoint alternative investigators or coordinators to continue the project subject to informing the other parties.
- P. Each Party reserves the right to withdraw from the project subject to giving a one month notice to the other Parties in which case the other Parties reserve the right to continue the project and utilize its results as deemed suitable.
- Q. In all cases however, the intellectual contributions of the investigators shall be retained.
