meta-analysis on Neoadjuvant chemo-radiotherapy. However, the questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 6 figures. (4) References: A total of 41 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A and Grade B. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide the approved grant application form(s). Please upload the approved
