The topic is within the scope of the WJP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors reviewed current literature about psychological and mental health's impact on healthcare workers during COVID-</p>	[Y]

19's pandemic. This topic is important. However, the questions raised by the reviewer should be answered; and (3) Format: There are no tables and figures. (4) References: A total of 58 references are cited, including 46 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
