The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The author discussed regarding the association of autoimmune pancreatitis and pancreatic cancer. This review is written in detail. Most of AIP patients receive immunosuppressive therapies (mainly glucocorticoids). How does this affect the characteristics of AIP that</p>	[Y]

described above? As you mentioned, chronic inflammatory processes will represent a risk factor for pancreatic cancer, however, does the risk decrease when the inflammation suppressed by the immunosuppressive therapies? The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. (4) References: A total of 69 references are cited, including 16 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 3 articles in the BPG. 5 Issues raised: The author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
