The topic is within the scope of the WJO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript reflects the experience of a major trauma center, in fractures which have no</p>	[Y]

specific treatment due to its diversity. It is a useful tool for surgeons unfamiliar with this type of injury. However, the questions raised by the reviewer should be answered; and (3) Format: There are 7 tables. (4) References: A total of 29 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The title, abstract and key words should be added in the first page; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and
