The topic is within the scope of the WJP. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The study evaluated the impact of perceived</p>	[Y]

family support on psychological distress in pregnant women during the COVID-19 pandemic. It is nicely written and adds to the literature. However, the questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. (4) References: A total of 31 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form. The authors should provide the Biostatistics Review Certificate, the Clinical Trial Registration Statement, and Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJP. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors

Please provide the original figure documents.
