limb. It is of interest to recognize the feasibility of applying PNE according to the circadian rhythm of pain. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 7 figures; (4) References: A total of 38 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
