The topic is within the scope of the WJGE. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors have done a noteworthy and laudable effort to address the effect of different pancreatic</p>	[Y]

endotherapy modalities on quality of life in patients suffering chronic pancreatitis. It is a well-designed and presented study. However, the questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 1 figure. (4) References: A total of 35 references are cited, including 14 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and PRISMA 2009 Checklist.
