The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The paper demonstrates that</p>	[Y]

laparoscopic cholecystectomy is safe also in patients with CF, while in the past concerns were raised. The wide sample size and the correct study design are the strengths of this study; (3) Format: There are 4 tables and 1 figure; (4) References: A total of 27 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
