tourism. However, the text avoiding unnecessary paragraphs should be shortened. The questions raised by the reviewer should be answered; and (3) Format: There are no tables and figures. (4) References: A total of 27 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJH. 5 Issues raised: (1) The authors should add some figures or tables. 6 Recommendation: Conditional acceptance.
