2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireview of the arthrodesis of the first metatarsophalangeal joint. The topic is within the scope of the WJO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an interesting and meaningful study. However, the authors should add two important conditions that may complicate the outcome.</p>	[Y]

The questions raised by the reviewers should be answered; and (3) Format: There are 10 figures. (4) References: A total of 52 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There are no self-cited references. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (5) Please obtain permission for the use of picture(s). If an author of

a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
