Science Editor: 1 Scientific quality: The manuscript describes a meta-analysis of the intragastric balloon in metabolic dysfunction-associated fatty liver disease. The topic is within the scope of the WJH. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an interesting, novel and well-written review. The limitation of the review is that the available resource articles are not sufficient, which may affect the robust and sound of the review. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 12 figures. (4) References: A total of 43 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and PRISMA 2009 Checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. The corresponding author has 6 published articles in the BPG.

Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Hepatology, and the manuscript is conditionally accepted.
