As the results, TMS was safe and effective method, and no definite risk of HBS was shown. The results were understandable and informative. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 4 figures; (4) References: A total of 72 references are cited, including 27 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
