Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors complete this observational study of sleep quality of patients with infective endocarditis following cardiac surgery, with follow up data collection at 6 months post-operatively. However, the authors did not mention how to deal with another comorbidities in cardiovascular that could influence the sleep disorder or maybe author could add the PSQI or ESS so reader could understand the item in the score. The questions raised by the reviewers should be answered; and (3) Format: There are 7 tables. (4) References: A total of 18 references are cited, including no references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
