Peer-Review Report: The authors found a good narrative on the trends of leadership in Orthopedic Fellowship programs, only one aspect which could have been bit highlighted, knowledge perception from the programs and also the physicians feedback on the program; and (3) Format: There are 3 tables and 3 figures. (4) References: A total of 35 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
