May 19, 2021 · SARS-CoV-2 emerged in December 2019 in Wuhan, China. By 17 April 2021, there were over 136.7 million confirmed cases and 3.0 million deaths, with a case fatality rate of 2.1% [16]. Gralinski and colleagues performed the first in vivo studies of SARS-CoV in C57BL/6J mice that showed complement activation as early as day 1 post-infection [11].
