The authors proposed a good paper with a quite large number of patients with adenocarcinoma of esophagoscope-gastric junction. However, the questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 1 figure. (4) References: A total of 26 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Gastrointestinal Endoscopy.</p>
