The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This manuscript is a sensible discussion of the conflicting and of course incomplete literature to date regarding effects of the novel coronavirus on the liver. It is well-written. However, the questions raised by the reviewers should be answered; and (3) Format: There</p>	[Y]

are 2 figures. (4) References: A total of 52 references are cited, including 43 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the [editorialoffice@wjgnet.com](mailto:editorialoffice@wjgnet.com).
