Report: This is a well written manuscript that focuses on a very important topic needed. A lot of studies have been reviewed, and also a lot of published works referenced. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 174 references are cited, including 58 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
