	clinical practice. The manuscript is too long, it would be better to	



talk about the treatment of DFU.. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 1 figure; (4) References: A total of 99 references are cited, including 22 references published in the last 3 years; (5) Self-cited references: There are 11 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated. 2 Language evaluation: Classification: Grade B and Grade B. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study.
