The topic is within the scope of the WJGO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is a systematic review of early outcomes with pooled analysis of endoscopic ultrasound guided radiofrequency ablation of solid pancreatic lesions. The authors reviewed 14 studies with 120 patients underwent 153 ablations of 129 solid pancreatic lesions and confirm the safety and feasibility of the EUS-guided RFA; (3) Format: There is 1 table and 3 figures; (4) References: A total of 28 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance.
