| | 6c | Relevant history including past interventions and outcomes | <u>5,6-7</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>5</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>5,6</u> |

| Interventions | 9a | Types such as life-style recommendations, treatments, medications, surgery | <u>6,7</u> |
