(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This review article highlighted the current literature on PSI in Total Ankle Arthroplasty, analyzing the current implants with PSI, templating and preoperative planning strategies, alignment and sizing, clinical outcomes, cost-analysis, and comparison with standard techniques. The questions raised by the reviewers should be answered; (3) Format: There is 1 table; (4) References: A total of 33 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
