The topic is within the scope of the WJSC. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: This paper comprehensively explained the mechanism of MSC in reducing the cognitive impairment caused by neuroinflammation. time, relevant studies were systematically analyzed to compare the effects of different types of mesenchymal stem cells on reducing neuroinflammation, and the content was relatively substantial. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 84 references are cited, including 44 references published in the last 3 years; (5) Self-cited references: There are 9 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
