written review on an interesting topic, the comparison between MSCs and EPCs on their immunoregulatory abilities could be useful in guiding future application. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 1 figure; (4) References: A total of 73 references are cited, including 25 references published in the last 3 years; (5) Self-cited references: There are 18 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
