work prepared by methodic review of the state-of-the-art of important cognitive disorders and its possible treatment by modification of the gut microbiota through the administration of probiotics, prebiotics, synbiotics or even fecal microbiota transplants. The information is clearly presented by the authors, updating the knowledge to the reader in this field of knowledge. However, the questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. (4) References: A total of 74 references are cited, including 28 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
