The topic is within the scope of the WJG. (1) Classification: Grade A, Grade C and Grade E; (2) Summary of the Peer-Review Report: The authors found a good attempt at writing an insightful article, which</p>	[Y]

explores radiogenomics in esophageal cancer. It is well-written and interesting. However, the grammatical and spelling mistakes need correction. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. (4) References: A total of 41 references are cited, including 15 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJG. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The authors did not provide the approved grant application form(s). Please upload the

Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) The "Article Highlights" section is missing.
