Science Editor: 1 Scientific quality: The manuscript describes a minireview of the sickle cell nephropathy. The topic is within the scope of the WJCP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This review has made an effort to combine the evidence on potential biomarkers that may play a role in the future in detecting subclinical kidney damage in patients with SCN. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 1 figure; (4) References: A total of 46 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
