The topic is within the scope of the WJP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors provided an updated review of the current scientific evidence on the relationship between S/R and mental health, and the mechanisms that explain</p>	[Y]

this relationship and the interventions that utilize this information in treating mental disorders was discussed. It is usefully to clinical practice that the findings reveal a large body of evidence across numerous psychiatric disorders. However, the mechanisms that explain these associations and the role of S/R interventions need further study; and (3) Format: There are no tables and figures. (4) References: A total of 114 references are cited, including 21 references published in the last 3 years; (5) Self-cited references: There are 21 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
